Founded in 1916 the Jericho Tennis Club is a premier racquets and fitness facility located in Vancouver, British Columbia. Boasting incredible views of the ocean and mountains, the Club is ideally situated on the Jericho Beach and caters to approximately 2800 members. Unique among west coast clubs, the Jericho Tennis Club blends competitive and recreational racquet sports, fitness and other activities in a casual social environment.

The Jericho Tennis Club is a non-profit organization governed by the Societies Act of British Columbia. The Club's affairs are administered by an elected Board of Directors according to all applicable laws of British Columbia, the Club's bylaws and the Club's rules through a management team. Elections are conducted annually for all positions on the Board.

Jericho Tennis Club serves its membership by providing facilities that promote racquet sports as well as supplementary recreational and social activities. These activities are carried out in an adult-oriented environment that respects and supports the facility and activity needs of its full membership, including families, juniors, and young adults.

## **Initiation Fees**

## Membership Categories

When applying for membership at the The Jericho Tennis Club you will be required to complete the application form in full and make a declaration for a category of membership. The following list is a breakdown of the different categories of membership available at the the Jericho Tennis Club. When applying for membership, it is advised that a prospective applicant speak to the Club's Membership Manager to fully understand the different categories and the respective privileges.

### Social Membership

- Social memberships are available to all adults age 32 and over. A Social membership entitles members to full use of the clubhouse facilities including dining, recreation, fitness, pool and spa facilities. Social members have very limited access to the playing facilities as prescribed by the Club rules. Access to the playing facilities can change at no notice to Social members.

### Squash Membership

- Squash memberships are available to all adults age 32 and over. A Squash membership entitles members to full use of the clubhouse facilities including dining, recreation, fitness, pool, and spa facilities including unlimited access to the squash playing facilities. Squash members are recognized as Social members with Squash playing privileges. Squash members have very limited access to the tennis courts as prescribed by the Club rules.

### Full Play Membership

- Full Play memberships are available to all adults age 32 and over. A Full Playing membership entitles members to unlimited access to the clubhouse, squash and tennis facilities. The Club maintains a quota of 850 Full Play members.

### Intermediate Membership

- Intermediate memberships are available to individuals between the ages of 17 to 31. There are intermediate equivalent categories for the Social, Squash and Full Play membership categories. Each Intermediate membership category has the same inherent privileges as the adult equivalent categories. There is presently a quota of 140 Intermediate Full Play members.

### Junior Memberships

- A Junior membership is available to individuals between the ages of 8 and 18. A Junior membership entitles the individual to restricted access to the clubhouse, squash and tennis facilities during prescribed times and days as set forth in the Club's rules. Individuals interested in applying for Junior membership are required to complete a separate application form available from the Club's Membership Manager. At the age of 19, a Junior membership ceases and they have no privileges of membership. Junior members may apply for an Intermediate membership at the age of 17, but must apply before the age of 19 for an Intermediate membership if they wish to continue being a member of the Club.

### Child of Member

A Child of a Member includes all children of members under the age of 19, who are not Junior members. A Child of Member **is not a member** of the Club but is accorded the same Clubhouse privileges as a Junior member. A Child of Member has no access to the playing facilities other than as a guest of a member. At the age of 19, Child of Member privileges cease. A Child of Member may apply for an Intermediate Social membership at the age of 17, but must apply before the age of 19 for an Intermediate Social Membership if they wish to be a member of the Club.



## **Procedures for Applying for Membership**

1. New applicants are required to complete the Jericho Tennis Club membership application form in full.
2. A non-refundable deposit cheque of \$3000 for adult applications or \$1500 for intermediate applications plus GST is required with the application form. The deposit will be applied as a credit against the entrance fee owing when membership privileges are offered at a later date. The entrance fee owing shall be the entrance fee in effect at the time membership privileges are offered.
3. All applicants will require a “Proposer” and “Secunder”, who are members in good standing of the Club, to sign the application form and provide letters of reference in support of the application. The complete requirements for the “Proposer” and “Secunder” are contained in Appendix (a) of the application form.
4. Two member references are also required to sign the application form. Member references can be of any membership category. No letters are required. Member references must know the individual applying for membership.
5. Direct family relations may act as a “Proposer” or a “Secunder”, not both. Direct family relations may provide one (1) of the two member references required, not both.
6. In the event that an applicant is unable to provide existing member references, then the applicant must have an interview with two members of the Club’s Executive. These individuals will act as the “Proposer” and “Secunder”. In lieu of letters of reference letters from the “Proposer” and “Secunder” the applicant must provide two letters of reference from the General Manager and member of an equivalent club or athletic organization. These letters will fulfill the requirements of the “Proposer” and “Secunder”. The letters must meet the requirements set in Appendix (a) section (5). In lieu of the two signed member references the applicant must provide two character letters of reference.
7. It is the responsibility of the applicant to provide the completed application form, the letters of reference and the deposit cheque to the Membership Manager for presentation to the Membership Committee for review.
8. Once an application is received, the applicant and their member Proposer will be required to meet with representatives of the Membership Committee to review their application and Club policies.
9. Following the Membership Committee’s review, the applicant’s name and completed application forms are “presented” to the Board of Directors at the next Board meeting following which the applicants name is posted for member review in the Club for twenty (20) days.



10. If at the end of twenty (20) days, and there are no objections, the application for membership will be forwarded to the Board of Directors for approval at their next Board meeting. Once approved, the entrance fee deposit cheque will be cashed and the applicant's name will be placed at the bottom of the **Applicant (No-Privilege) Wait List**. Once cashed, the entrance fee deposit is non-refundable. Details regarding the Club's wait list policies are contained in Appendix (b).
11. Individuals whose application for membership have been approved and names placed on the Applicant (No-Privilege) Wait List **are not members** of the Club. Their membership application has been pre-approved waiting for a membership. Applicants on the Applicant (No Privilege) Wait List will become members **only** when a membership position is offered **at a later date**.
12. If an application is declined, the applicant will be contacted and the deposit cheque returned.
13. Quarterly, the Membership committee reviews the membership levels and makes recommendations to the Board as to how many applicants, if any, may be admitted into the Club from the Applicant (No Privilege) Wait List.
14. Once a membership position is offered, social membership applicants will have twenty one (21) days to accept the offer of a membership position and pay the outstanding balance of the entrance fee owing. Full Play membership applicants will have twenty one (21) days to accept the offer of membership privileges and pay the outstanding balance of the entrance fee owing less half the differential between the Full Play initiation fee and the Social initiation fee. Intermediate applicants for social and playing membership have the option of taking advantage of an installment payment plan for the payment of their entrance fees owing.
15. For Full Play membership applications, the final payment of the entrance fees is due upon the offer and acceptance of a Full Play membership, at which time the member will be offered a voting certificate upon payment of \$100. The voting certificate permits the member to vote in the affairs of the Club. The wait list details and movement to the Full Play membership are explained in Appendix (b)
16. Applicants that apply for a Full Play membership are subject to the Club's Playing Wait List Policies contained in Appendix (b). An applicant's name is not placed on the Playing Wait List until they have been offered a membership position. Placement on the Playing Wait Lists does not guarantee a playing position will come available at any particular time.
17. If the applicant chooses not to accept the offer of membership privileges, the applicant may request to go to the bottom of the **Applicant (No-Privilege) Wait List**. If, in the future, an applicant is offered a membership position for a second time, and refuses, their application will be removed from the list and will forfeit any claim to possible membership or payments made.
18. The Club takes no responsibility for the length of time an applicant may spend on the **Applicant (No-Privilege) Wait List**. Any estimates provided are based exclusively on the past movement of the Applicant (No-Privilege) Wait List and is non-binding as the Club cannot predict the future movement of the membership.



## Appendix (a)

### Requirements for the Proposer and Seconder

1. When proposing or seconding a new member, your first responsibility is to the Club and its members, not the applicant. As an advocate for the applicant, you are taking responsibility for the applicant's character and background. You must know the applicant well and be sure the applicant will be a good member.
2. As the "Proposer" and "Seconder" you are agreeing to act as a mentor and goodwill ambassador for the applicant and promise to assist in the integration of the applicant into the Club's organization and culture. You will be responsible for insuring the applicant understands the rules and policies of the Club.
3. The "Proposer" and "Seconder" must be members in good standing of the Club for a minimum of three (3) years.
4. The "Proposer" and "Seconder" must have known the applicant well for at least three (3) years.
5. As the "Proposer" and "Seconder" you will both be required to submit letters of reference for the applicant. You will need to demonstrate a substantial personal knowledge of the applicant's character and background. Letters indicating a business or professional relationship only, will not be considered favourably. The letters shall include the following:
  - a. Length and type of acquaintance.
  - b. Why the applicant should be considered for membership.
  - c. You acknowledge your responsibility to assist with the integration of the applicant into the Club's organization and culture.
  - d. That, to the best of your knowledge, the applicant has no known impediments that would preclude membership.
  - e. When applying for a playing membership, the reference letter should indicate a strong knowledge of the applicant's playing ability and or ranking.
6. Direct family relations may act as a "Proposer" or a "Seconder", not both. Direct family relations may provide one (1) of the two member references required, not both.
7. No member shall propose or second more than two candidates in any twelve-month period, based on the date of submissions of the application.
8. The "Proposer", "Seconder" and References are encouraged to consult with the Club's General Manager, Membership Manager or Membership Chair for any advice of the foregoing guidelines.

### Requirements for the Member Reference

1. When signing an application your first responsibility is to the Club and its members, you are taking responsibility for the applicant's character and background; you must know of them and be confident they will be a good member.
2. If an applicant is applying for a Playing membership you must have a strong knowledge of the applicant's playing ability.
3. If you are unable to meet the requirements stated in 1 & 2 you cannot sign the applicant's application.



## Appendix (b)

### Wait List Policies and Procedures

The Jericho Tennis Club maintains a membership of approximately 2600 adult members in all categories of membership. When joining the Club, members will be required to place their name on a wait list if they are applying for a Full Play membership. The Full Play playing membership categories are governed by quotas. Movement into the Full Play membership category is based on attrition and movement between categories of the existing membership. Contained below is a summary of the policies and procedures for the movement of an applicant into the club and through the appropriate wait lists.

#### Prioritization of Applicants

- The Club has established membership policies that identify future membership growth from two sources (internal and non-related applicants). Internal applicants (spouses and children under the age of 32) will be admitted on a 3 to 1 ratio vs. non-related applicants.

#### Applicant (No-Privilege) Wait List

- Once your application for membership is approved you will be placed on the applicable Applicant (No-Privilege) Wait List (internal or non-related) as per the Clubs operating policies. While on this list you are not a member and will have no privileges of membership or access to the Club other than as a guest of a member. On a quarterly basis, the Club reviews the membership requirements of the Club to decide what, if any, applications can be accepted into the membership. The entrance fee owing shall be the entrance fee in effect at the time membership privileges are offered.
- Once a membership position becomes available, you will be contacted and offered a membership within the Club. Social membership applicants will have twenty one (21) days to accept the offer of a membership position and pay the outstanding balance of the entrance fee owing. Full Play membership applicants will have twenty one (21) days to accept the offer of a membership position and pay the outstanding balance of the entrance fee owing. Intermediate applicants for social and playing membership positions have the option of taking advantage of Club sponsored financing options for the payment of their entrance fees owing. If you choose to not accept the offer of membership, you may request to go to the bottom of the Applicant (No-Privilege) Wait List. If in the future you are offered a membership for a second time, and you decline, your name will be removed from the list and you will forfeit any claim to membership and payments made.
- If you are applying for a Full Play membership you will first be offered a Social membership while waiting for playing privileges. Your name will be added to the Full Play Wait List or Intermediate Full Play Wait List. As a member on the Full Play Wait List or Intermediate Full Play Wait List you will have limited access to the tennis playing facilities.
- If you are applying for a Social membership you will be offered a Social membership with the inherent privileges associated with the category.
- If you are applying for a Squash membership you will be offered a Social membership with squash privileges. There is no wait list for squash privileges once you are offered membership privileges.



## Appendix (b)

- Your name is only added to the Full Play Wait List or the Intermediate Full Play Wait List once you have come off the Applicants (No Privilege) Wait List and been offered and accepted a membership position within the Club.
- The Club takes no responsibility for the length of time an applicant may spend on the Applicant (No-Privileges) Wait List. Any estimates provided to you, are based exclusively on the past movement of the Applicant (No-Privilege) Wait List and is non-binding as the Club cannot predict the future movement of the membership.

### Full Play Wait List

- As a member on the Full Play Wait List your official status is as a Social Member waiting for Full Play privileges. As a Social Member waiting for playing privileges, you will have limited access to the playing facilities as outlined in the Club's rule book. The rules governing privileges for wait list members can, and do change, from time to time based on the needs of the Club.
- At some point in the future, the Club may be able to offer you **temporary** Full Play privileges prior to your acceptance as a Full Play Member. The temporary Full Play privileges are the result of an internal program allowing Full Play Members the opportunity to relinquish their playing privileges on an indefinite basis, allowing a Full Play Wait List member the opportunity to occupy their position. These privileges, when granted are temporary and can be revoked by Full Play Members returning to the Full Play category.
- When your name reaches the top of the Full Play Wait List and a Full Play Position is available you will be offered a Full Play membership. You will be required to pay the final amount owing of your Entrance Fee plus \$100 for a membership certificate that entitles you to vote in the affairs of the Club. At this point you become a Full Play member with all of the inherent privileges associated with this position. If you decline the opportunity to become a Full Play member you will be removed from the wait list and you will become a Social member with the inherent privileges associated with that category.
- The Club takes no responsibility for the length of time you may spend on the Full Play Wait List waiting for Full Play privileges or a Full Play membership. Any estimate you are provided is based exclusively on the past movement of the Full Play Wait List and is non-binding as the Club cannot predict the future movement of the membership.

### Intermediate Full Play Wait List

- As a member on the Intermediate Full Play Wait List your official status is as an Intermediate Social Member waiting for Intermediate Full Play privileges. As an Intermediate Social Member waiting for playing privileges, you will have limited access to the playing facilities as outlined in the Club rule book. The rules governing privileges for wait list members can and do change from time to time.
- When your name reaches the top of the Intermediate Full Play Wait List and an Intermediate Full Play position is available, you will be offered an Intermediate Full Play membership. Intermediate members who are financing the outstanding balance of their entrance fees will not be offered a voting certificate until such time that the entire outstanding balance of their entrance fees are paid. If you refuse the opportunity to become an Intermediate Full Play member you will be removed

from the wait list and you will become an Intermediate Social member with the inherent privileges associated with the Social category.

- Intermediate Full Play members are required to transition to the adult Full Play category at the age of 32. Intermediate Full Play members who applied for membership before the age of 27 will move to the top of the adult Full Play Wait List and will be prioritized for the next available Full Play membership position.
- At the age of 32, Intermediate Full Play members who applied for membership between the ages of 27 to 31 will be inserted on the adult Full Play Wait List based on the date order of the application. Intermediate Full Play members who applied for membership between the ages of 27 to 31 may lose their playing privileges when transitioning out of the Intermediate category due to the adult Full Play Wait List. Your wait list eligibility is backdated to your original date of application and will be considered for playing privileges in chronological order of all adult Full Play applications. Your membership category reverts to a Social membership waiting for a Full Play position. Intermediate Full Play members who applied between the ages of 27 to 31 need to clearly understand the Full Play Wait List and the implications of movement and eligibility for playing status.
- The Club takes no responsibility for the length of time you may spend on the Intermediate Full Play Wait List waiting for Intermediate Full Play privileges. Any estimate you are provided is based exclusively on the past movement of the Intermediate Full Play Wait List and is non-binding as the Club cannot predict the future movement of the membership.

Please read the following stipulations regarding membership at the Jericho Tennis Club and your understanding of the guidelines and requirements of membership, and sign at the bottom to indicate your agreement. The Application Declaration must be returned with your Membership Application Form.

- a. The information I/we have provided is true and accurate.
- b. I/we have read the application form and appendices and fully understand the material, including the Club's Membership Categories and Wait List Policies and Procedures.
- c. If my/our application is accepted, I/we hereby agree to abide by the ByLaws and Rules passed by the Jericho Tennis Club at any time I/we am a member thereof, and to pay all dues, fees and assessments set by the Jericho Tennis Club.
- d. I/we understand that the Jericho Tennis Club is an adult oriented Club that has restrictions on the hours and areas of use of the entire facility for all individuals under the age of 19.
- e. I/we understand and agree that my entrance fee is non-refundable and non-transferable in whole or in part.
- f. I/we understand that the admission of new members from the Applicants (No Privilege) Wait List is prioritized between internal applicants and non-related applicants on a three (3) to one (1) ratio. Internal applicants are spouses of existing members and children of existing members under the age of 32.
- g. I/we understand and agree that the total entrance fee payable shall be the entrance fee rate in effect at the time a membership position is offered.
- h. I/we understand and agree that once I/we accept a membership position, I/we are required to pay the outstanding balance of the entrance fee owing.
- i. I/we understand that the Club has quotas within certain categories and an overall target level of members. I/we understand that movement into the Club from the Applicant (No Privilege) Wait List is based on the attrition of existing members, and the movement of existing members in and out of categories.
- j. I/we understand and agree that as an applicant on the Applicant (No-Privilege) Wait List, I/we acknowledge that we are not members of the Jericho Tennis Club, and have no privileges of membership until such time a membership position is offered.
- k. I/we understand and agree that membership privileges are subject to change from time to time without notice to members on the Applicant (No-Privilege) Wait List.
- l. I/we understand and agree that Wait List members, Intermediate Full Play Wait List Wait List members, Full Play Wait List members, and Social Members are not entitled to vote in the affairs of the Club.

- m. I/we understand that there is a lengthy wait list for membership at the Jericho Tennis Club. I /we understand that the Club takes no responsibility for the length of time I/we may spend on the Applicant (No-Privilege) Wait List, the Intermediate Full Play Wait List and the Full Play Wait List. I/we acknowledge that the current wait list procedures have been explained to me and that no representations have been made as to when I may receive privileges.
- n. I/we acknowledge that any estimates I/we may have been given are based exclusively on the past movement of the wait lists and are considered non-binding as the Club is unable to predict future movement of membership.
- o. If I am an Intermediate Full Play applicant who is applying between the ages of 27 to 31, I/we understand and agree to accept the policies and guidelines that govern the future movement of Intermediate Full Play applicants between the ages of 27 and 31 into the Full Play category.
- p. I/we understand and agree that the Board of Directors, at their discretion, and in the best interests of the membership can, and do, change the rules of the Club. As a condition of your acceptance of membership you are expected to understand that rules may change and alter privileges to which you thought you were entitled to.
- q. The Jericho Tennis Club offers discounts on the entrance fee and monthly dues for spousal memberships and permits couples to have two different membership types. I/we understand and agree that the spousal discount is always applied to the lesser valued membership category.
